Commr. (CPIO), CBIC, Legal. Further it is mentioned that aforesaid two RTI applications dated 26.03.2025 and 25.03.2025 filed by has been transferred under Section 6(3) of the RTI Act, 2005, and for furnishing the requisite information directly to the applicant.

2. The applicant is seeking following information:

(I) RTI application Registration No..CBECC/R/T/25/00083 dated 25.03.2025

" This is in respect of a research that I am carrying out regarding pending tax cases in India. For this, I require the latest number of appeals pending before various legal forums and adjudicating authorities, especially in the case of customs."

(II) RTI application Registration No.CBECC/R/E/25/00189 dated 26.03.2025

"In respect of a research that we are doing, we would like to know the latest number of pending GST litigation at the following levels

1. Adjudication Level (Commissioner, Additional / Joint Comm./ Deputy / Assistant Comm., Superintendent)
2. Appellate Level
3. High Court
4. Supreme Court

We request litigation details pending at the pre-SCN /SCN level and appeals filed and for how many years the same have been pending (age-wise categorization)

Similarly, we request the same for Service Tax/Excise Tax/ Customs.

We would glad if you could provide us with the latest data."

3. As regards to above requests, it is to inform that this office i.e. Directorate General of Valuation, Mumbai, is not the concerned Public Authority which possess the information sought by applicant, hence information cannot be provided.
